There is no route suitable for beginners Classes A & F ride the harder sections with red & blue cards. Class C rides hard middle orange route Classes D, E, & G ride the easier middle route yellow sections suitable for novices. Class H rides the white easy route. The Trial will be observed as NO STOP in accordance with TSR22B. No riding at the venue before or after the trial. All bikes to be pushed to the start area with dead engines for 10.00am start.
